Controls foul smelling odors caused by mildew, fungi, bacteria, algae and slime. For use in hotels, motels, schools, colleges, hospitals, nursing homes and airports. Effective against odor-causing bacteria. For use in floor drains found in food processing plants, bars & restaurants. **T.R. Bio Klean** is a controlled release product that easily fits into most air conditioners, refrigerator drip pans or the water tank of your dehumidifier. Because of the controlled release mechanism, **T.R. Bio Klean** will last up to several weeks effectively maintaining clean water and inhibiting the foul odors caused by mildew.

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**DANGER CORROSIVE** Causes irreversible eye damage and skin burns. Do not get in eyes, on skin or on clothing.
